The 2017 AARES Conference - Highlights

"Transformations in food, energy and the environment"

Australia and NZ have very different natural environments, but face many similar environmental issues. Developing policy to manage agricultural pests and diseases was the topic of one of seven mini-symposia at the AARES conference, where case studies provided the means of thinking about the role of commodity and food prices in developing pest management policy. In another mini-symposium with a topic less familiar to NZ, speakers tackled the issue of economic efficiency of recycling water, and the social aspects of water security through recycled water.

A topic of one of the two preconference workshops was exploring the economic, social and environmental aspects of land clearing in Australia, and included a wide ranging discussion from the history of land clearance to policy mechanisms and economic instruments.
