### 1. Minutes of the 2012 AGM

### 2. Matters arising from the 2012 Minutes

#### a. Old papers

Old NZARES papers are available from the Lincoln Library archive and a note has been placed on the website with a link to the archive.

#### b. Special sessions policy

This was finalised based on feedback at the 2012 AGM, and uploaded to the NZARES website.

#### c. Conference registration form

Improvements were made to the conference registration form especially clarifying membership language. The idea for corporate registration raised at the 2012 AGM was considered by the webmaster but not included; this may be considered next year. Late cancellation fee of \$40 was included this year, as approved at the 2012 AGM, which helped to manage late catering booking changes.

#### d. Revised best paper judging process

This was finalised based on feedback at the 2012 AGM, and uploaded to the NZARES website. An opt-out option was included on the abstract submission page, and has proved to be more successful than the opt-in option last year (21 papers versus a small handful last year). Irene Parminter, Convenor of the Conference Paper Award Judging Panel, noted that the new process was much more effective. In particular requiring that papers be available prior to the conference for pre-judging meant that the judges could properly consider their content.

### **4. Matters arising from the President's report**

#### **Field trip**

Members expressed positive feedback about the field trip and a desire for more in the future. It noted that including a field trip in the programme did result in an additional burden for the Committee. Notwithstanding that, given the excellent attendance and value that people got out of it, perhaps it was something to consider every second year. It was suggested that cooperating with other professional societies such as the New Zealand Institute of Primary Industry Managers (NZIPIM) could be one way of both achieving cross-fertilisation of conference attendance and sharing the burden of arranging field trips.

#### **Cooperation with other societies**

While the primary reason for shifting the conference from Nelson to Lincoln was to cooperate with the Australasia-Pacific Extension Network (APEN) international conference, the two events were not aligned as well as they could have been. It was noted that the NZARES Committee did try very hard to align the events nonetheless. There was good feedback from those who took advantage of the collaboration to attend both events.

#### **Publicity on major issues**

There was a generally positive reaction to publicising the work of NZARES, by for example, summarising invited papers / speakers presentations and including those in a media release. On the other hand members were reluctant for NZARES to express 'a position' when there was such diversity in members views. A caution was made against doing such a press release quickly and without specific media expertise. The point was also made that one objective of the contributed paper sessions was to have a safe environment for peers to test and question each other's work and so it would be inappropriate for these papers to be included in any publicity exercise.

Stephanie McWhinnie noted that AARES plays a facilitatory role where they invite media (e.g. TV and radio shows, print media) to their conferences and arrange press releases around certain individuals' work that was showcased at the event. For example, NZARES could prepare a press statement stating the themes that were discussed at the conference and include a 200 word summary of the keynote speakers' addresses. It is a good opportunity to highlight the need for economic analysis to underpin decision-making.

Terry Parminter noted that he was recently talking to a newspaper journalist who asked for information about the conference and whether anything would be published. So perhaps these are things we could think about in planning for the 2014 conference. Suzi Kerr noted that there is a science media grouping that we may wish to tap into.

This concept is hereby referred to both the incoming NZARES committee for 2013-14 and the local organising committee (LOC) for the joint AARES-NZARES conference in 2015.

## 8. General Business

### a. NZARES 2014 and 2015

With the joint NZARES-AARES conference being held in Rotorua in February 2015, the Committee sought members' preferences for the location and timing of NZARES events in August 2014 and 2015. In 2007, following the joint conference a one-day symposium was held in Wellington but was poorly attended. Rod Forbes commented that the NZARES constitution requires an AGM each year. Matt Newman pointed out that the pressure on the Committee would be a double banger. It was noted that AARES arranged a panel for

contributed paper sessions, and other support so that would take the pressure off. Annie Perkins suggested that it would be logical to cooperate with NZIPIM, not next year but perhaps for the 2015 symposium (and AGM) to avoid the poor turn-out experience in 2007? Returning to the normal conference in 2016.

Question about whether we would use the AARES conference organiser for the 2015 joint conference? Geoff Kerr mentioned that AARES had changed their organiser at the 2013 conference and suggested finding out how the new organisers performed.

Motion: Hold the next NZARES Conference in Nelson Aug 2014, the joint NZARES-AARES Conference in Feb 2015 in Rotorua, and a 1 day symposium in Aug 2015 (venue tbc).

**b. Simplifying membership fees. Especially changing the timing of invoicing to better coincide with the conference?**

Members discussed confusion in the membership fee structure and the need to simplify it. It was noted that the invoicing process was also about checking in with members in case they are members of AARES (in which case do not need to pay their NZARES fee). There were also legal and accounting requirements that influenced when members had to be invoiced and stopped alignment with conference fees.

The matter was referred to the incoming committee to do some work on the legal requirements and options for how membership payments could be simplified with that in mind.
